

PYREG becomes the first endorsed technology provider by Puro.earth

German NetZero tech company is the first technology provider to be endorsed by carbon crediting platform and Nasdaq subsidiary Puro earth.

Dörth / Helsinki 27 July 2023: German mechanical engineering company PYREG GmbH and European market leader in manufacturing facilities for permanent carbon dioxide (CO₂) removal through biochar, becomes the provider to be endorsed by Puro.earth. The Nasdaq subsidiary is the world's leading crediting platform for engineered carbon removal.

With this endorsement, PYREG's BCR (Biochar Carbon Removal) technology becomes the first of all carbon removal technologies to receive "Endorsed Technology Provider" status from Puro.earth. With this recognition, PYREG's carbonisation plants meet the strict technical requirements of the Puro Standard for carbon removal credits, so-called CO₂ Removal Certificates (CORCs). This is not only with regard to the quality of the end product Biochar but in particular with regard to the production process through PYREG's technology, which can comply with all emission limits set worldwide.

PYREG's plants enable the industrial carbonisation of biogenic residues for the permanent removal and binding of CO₂ from the atmosphere in the form of high-quality biochar. The patented and certified carbonisation technology stabilizes CO₂ from the atmosphere to be stored e.g. as a soil improvement substance. PYREG's flagship, the PX1500, can sequester as much CO₂ as 180,000 trees bind in a year. More than 50 plants are now in operation worldwide.

"We are very pleased about the recognition of our technology by Puro.earth as an 'Endorsed Provider', says Jörg zu Dohna, CEO of PYREG. And he emphasises: "Confidence in the carbon removal market and thus in the



financial viability of the technologies will only develop further if BCR technologies meet international industrial and environmental standards in every respect. By raising the quality requirements for carbon removal technologies, Puro.earth is sending a clear message to CDR market participants." Through the Puro Accelerate programme, they have the opportunity to secure funding for their projects and thus make a relevant contribution to the Paris Carbon Removal targets.

"PYREG is a pioneer in the biochar sector. PYREG machines produce high quality biochar that meets the strict approval requirements of the Puro Standard. This endorsement aims to enable biochar producers to monetise and finance their carbon removal activities. Together, we want to advance the scaling of CDR technology as an important contribution to combating climate change," says Antti Vihavainen, co-founder and CEO of Puro.earth.
